4 DAYS LEFT TO PURCHASE SHARES ~ then, that's it folks!!

£374,021 is in the bank, and 267 members have invested so far, a huge thank you to our members. Some of you have also increase your original purchase, the average investment is now £1,377.

£475,000 Share capital target

£100,979 still to go in the next 4 days

Remember that shares can be gifted, your local gardener and cleaning staff, son, daughter, grandchildren and spouse/civil partner. For some that can be set against your tax bill.

Community Ownership Fund: Grant Application

Over 200 hours of the committee's time last was spent this month in putting the submission together for Community Ownership Fund. A "Thank You" to the businesses and organisations that have sent letters of support – the final document was submitted by 19th August. If successful, this would bring us to the minimum capital target of £510,000 as well as make a contribution to initial running costs of the community owned Havards. Fingers crossed!
